



IFL Player Contract

This Contract is between “League” _____ and “Player” _____ to form this (Partnership) as a member of the Ironman Football League, In consideration of the promises made by each to each other, Player and League agree as follows:

This Contract covers the full length of seasons in which the “player” participates and/or is a member of the Ironman Football League. And will begin on the date in which this contract is signed.

SERVICES. The Ironman Football League recognizes that the “player” is skilled and can play the game. The “Player” agrees to give his best efforts and loyalty to the “league”, and conduct himself on and off the field with appropriate recognition of the fact that the success of semi-pro football in general depends largely on public respect for and approval of those associated with the game. “Player” will promptly participate in his team practices and functions that are scheduled by his team. If invited, player will practice for and play in any all-star football game sponsored by the league. “Player” will not participate in any football game for which he is monetarily or otherwise compensated by any non-member league or team unless the game is first approved for by the “league”.

PUBLICITY AND IFLLC LICENSING, “Player” grants his team and the “league”, separately and together, the authority to use his name and picture for publicity and the promotion of the Ironman Football League, the “league” or any of its member teams in newspapers, magazines, motion pictures, game programs and roster manuals, broadcasts and telecasts, and all other publicity and advertising media, provided such publicity and promotion does not constitute an endorsement by “player” of a commercial product, “player” will cooperate with all league affiliated media, and will participate upon request in reasonable activities to promote the team and the “league”. The Ironman Football League reserves the right to produce, sell, market or distribute any and all football game film footage for all of the leagues interactive uses.

COMPENSATION AND BUY-OUT, If “Player” wants to join a league or team who is non-members of the “League” in which the “player” is monetarily or otherwise compensated, the “player” must receive expressed written consent by the Ironman Football League to do so. If “Player” is offered and signs a monetary contract by a league or team who are not members of the Ironman Football League, a set 10% of the full monetary contract must be paid to the Ironman Football League once “Player” signs. The percentage (10%) of the full contract is agreed by both the “Player” and the “League”. 5% will be paid to the player’s former IFL team, the other 5% will be paid to the “League”.

RULES, "Player" will comply with and be bound by all reasonable team rules and regulations in effect during the term of this contract.

INTEGRITY OF GAME, "Player" recognizes the detriment to the "league" and Semi-pro football that would result from impairment of public confidence in the honest and orderly conduct of IFL games or the integrity and good character of IFL players. "Player" therefore acknowledges his awareness that if he accepts a bribe or agrees to throw or fix an IFL game, fails to promptly report a bribe offer or an attempt to throw or fix an IFL game, bets on an IFL game, knowingly associates with gamblers or gambling activity, uses or provides other players with stimulants or any other drugs for the purpose of attempting to enhance on-field performance, or found guilty by the commissioner to be detrimental to the league, the commissioner will have the right to fine, suspend or expel "player" for a period certain or indefinitely, and/or to terminate this contract.

PROVISIONS, each of the undersigned hereby confirms this contract to be official and each will receive a copy of this contract.

"Player" acknowledges that before signing this contract he fully understands what this contract entitles and agrees to the terms of this contract.
